Pursuant to Minnesota Statutes 1969 Sections 16.125, 16.13 and 16.135, I Richard L. Brubacher, as Commissioner of Administration do hereby order the transfer of employees, functions, and appropriations as set forth below and as approved by the Governor, such order to become effective on July 1, 1970.

The functions currently assigned to the Track and Hopper Scale unit of the Grain Inspection Division of the Department of Public Service are transferred to the Division of Weights and Measures. Such functions are referred to in Minnesota Statutes 1969 Sections 229.06 and 233.24.

The six positions authorized for said Track and Hopper Scale unit are transferred to the Division of Weights and Measures, increasing the approved complement from 39 to 45.


The following transfer of appropriations are made:

\$58,982.00 from Grain Inspection Salaries (Laws of 1969 Chapter 1139, Sec. 31, Subdivision 3a) to the division of weights and measures (Laws of 1969 Sec. 31, Subdivision 2a).

\$4,900.00 from grain inspection - supplies and expense (Laws of 1969 Chapter 1139, Sec. 31, Subdivision 3b) to the division of weights and measures - supplies and expense (Laws of 1969 Chapter 1139, Sec. 31, Subdivision 2b).

The above transfer will facilitate the interchange of employees performing similar functions and result in an economy in operation within the Public Service Department.
