REORGANIZATION ORDER NO. 108

Pursuant to Minnesota Statutes 1978, Section 16.125, the following administrative reorganization is made with prior approval of the Governor to Executive Order Number 79-35.

In order to avoid duplication and improve efficiency, the duties including but not limited to those of Executive Order No. 79-10, budgeting, revolving fund, staffing, and supplies of the Minnesota Occupational Information System Board are transferred by this reorganization order to the Commissioner of Education.

The following legislative authorized complement, necessary to perform these duties, and their incumbents at their approximate current salary rate with all earned sick leave and annual leave are transferred from the Minnesota Occupational Information System Board to the Commissioner of Education.

The approved legislative authorized complement of MOIS is decreased by twelve positions and the approved budgetary authorized complement of the Commissioner of Education is increased by twelve positions.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1978, Section 16.125, Subdivision 3.

The appropriate transfer of equipment, furnishings, and supplies will be made as agreed by the involved agencies. Copies of the lists of equipment, furnishings, and supplies are on file in the Department of Administration.

Any grant agreement or other contractual agreement that is outstanding shall be amended to reflect the change in responsible state agency.

The effective date of this order is November 7, 1979. The order is herewith filed with the Secretary of State and shall remain in effect until amended or superseded by proper authority, or July 1, 1980, whichever is earlier.
