STATE OF MINNESOTA DEPARTMENT OF ADMINISTRACION REORGANIZATION ORDER NO. 120

Pursuant to Minnesota Statutes, 1980, Section 16.125, the following administrative reorganization order is made with prior approval of the Governor.

In order to improve efficiency and avoid duplication of effort in the operation of state government, the State Soil and Water Conservation Board, with all its powers, authorities, and funding is transferred from the Department of Natural Resources to the Department of Agriculture.

The following positions and incumbents, with all accrued benefits, are transferred from the Department of Natural Resources to the Department of Agriculture. The legislative complement of the Department of Natural Resources is decreased by sixteen positions and the legislative complement of the Department of Agriculture is increased by sixteen positions.

Transfer of equipment, furnishings, supplies, and space lease will be made as agreed by the involved agencies. Copies of lists of equipment and furnishings are on file with the Department of Administration.

Any grant agreements or other contractual agreements shall be amended to reflect the change in responsible state agency.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1980, Section 16.125, Subd. 3.

The effective date of this order is July 1, 1982. The order is herewith filed with the Secretary of State and shall remain in effect until amended or repealed.
