REORGANIZATION ORDER NO. 127

Pursuant to Minnesota Statutes, Section 16.125, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and to avoid duplication in the operation of state government, certain powers and duties of the Department and ~~Commissioner~~ of Administration related to the Minnesota State History Center are transferred to the Capitol Area Architectural Planning Board (the "Board") and Executive Director thereof as following described. Transferred are the specific powers and duties described in Minnesota Laws 1983, Chapter 334, Section 2(f) and to the extent necessary those powers and duties necessary to effectuate the aforementioned, subject to the following conditions on the use of the appropriation contained in said Chapter 334, Section 2(f):

- 1) \$250,000 is to be used for design competition purposes.
- 2) \$8,000 is to be used for site testing and similar requirements.
- 3) \$110,000 is to be used for a program and structural plan and urban design framework study as determined by the Minnesota State Historical Society.
- 4) \$8,000 is to be used for library museum, archival, technical support consulting need studies conducted by the Minnesota State Historical Society.
- 5) \$24,000 may be used for contingency purposes agreed to by the Board, the Minnesota State Historical Society and the Commissioner of Administration.

No positions are transferred.

In accordance with Minnesota Statutes 1982, Section 16.125, this order is effective upon filing with the Secretary of State and shall remain in effect until amended or superseded.
