REORGANIZATION ORDER NO. 147 D L

Pursuant to Minnesota Statutes 1986, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the duties of the Office of Full Productivity and Opportunity, the Department of Jobs and Training, and the Department of Human Services, to coordinate and evaluate the implementation of a comprehensive state employment and training policy are transferred to the State Planning Agency.

Consistent with this transfer of duties, the following personnel, with all accrued benefits, are transferred from the Office of Full Productivity and Opportunity to the State Planning Agency:

Two general fund complement positions shall be transferred from the Department of Jobs and Training to the State Planning Agency. The general fund complement of the Department of Jobs and Training, as provided in Laws 1987, Chapter 403, Article 1, Section 4, is decreased by two positions; the general fund complement of the State Planning Agency, as provided in Laws 1987, Chapter 404, Section 29, is increased by two positions.

The Office of Full Productivity and Opportunity, the Department of Jobs and Training, and the Department of Human Services shall give the State Planning Agency all contracts, books, maps, plans, records, equipment, and supplies related to the transferred duties.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the State Planning Agency in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Office of Full Productivity and Opportunity.

The effective date of this order is June 30, 1987. The order is herewith filed with the Secretary of State and shall remain in effect until amended or repealed.
