REORGANIZATION ORDER NO. 156

Pursuant to Minnesota Statutes 1988, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency, avoid duplication in the operation of state government and carry out the provisions of Minnesota Laws 1989, Chapter 334, the Department of Revenue's duties for processing gambling license applications are transferred to the Department of Gaming, Division of Gambling Control.

Consistent with this transfer of duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Department of Revenue to the Department of Gaming, Division of Gambling Control:

One additional position authorized by Minnesota Laws 1989, Chapter 335, Article 1, Section 19, but not yet established, shall be transferred from the Department of Revenue to the Department of Gaming, Division of Gambling Control.

In order to improve efficiency, avoid duplication in the operation of state government and carry out the provisions of Minnesota Laws 1989, Chapter 334, the Department of Revenue's duties for auditing and investigating gambling under Minnesota Statutes 1988, Chapter 346, except for auditing tax returns, are transferred to the Department of Public Safety.

Two positions authorized by Minnesota Laws 1989, Chapter 335, Article 1, Section 19, but not yet established, shall be transferred from the Department of Revenue to the Department of Public Safety.

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1988, section 43A.18 or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The general fund complement of the Department of Revenue as provided by Minnesota Laws 1989, Chapter 335, Article 1, Section 19 is decreased by 15 positions; the general fund complement of the Department of Gaming as provided by Minnesota Laws 1989, Chapter 334 is increased by 13 positions; and the general fund complement of the Department of Public Safety as provided by Minnesota Laws 1989, Chapter 269, Section 5 is increased by 2 positions.

The Department of Revenue shall give to the Department of Gaming and Department of Public Safety all contracts, books, maps, plans, papers, records, supplies, and equipment relating to their respective transferred duties.

Rulemaking authority for the respective transferred duties is transferred to the Department of Gaming and Department of Public Safety. All rules adopted by the Department of Revenue pursuant to these duties remain in effect and shall be enforced until amended or repealed in accordance with law by the Department of Gaming or Department of Public Safety.


Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Gaming or Department of Public Safety for their respective transferred duties in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Department of Revenue.

The Department of Gaming and Department of Public Safety are the legal successors in all respects of the Department of Revenue in regard to the respective transferred duties. The bonds, resolutions, contracts, and liabilities of the Department of Revenue become the bonds, resolutions, contracts, and liabilities of the Department of Gaming or Department of Public Safety.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1988, Section 16B.37, Subdivision 3.

In accordance with Minnesota Statutes 1988, Section 16B.37, Subdivision 2, this order is effective upon filing with the Secretary of State and shall remain in effect until amended or repealed.


