REORGANIZATION ORDER NO. 163

Pursuant to Minnesota Statutes 1990, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency, avoid duplication in the operation of state government, and implement provisions of Minnesota Laws 1991, Chapter 345, the duties of the State Planning Agency with respect to dispute resolution are transferred to the Department of Administration.

Consistent with this transfer of duties, the following position and its incumbent, with all accrued benefits, is transferred from the State Planning Agency to the Department of Administration:

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1990, Section 43A.18, or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The general fund complement of the Department of Administration, as provided in Minnesota Laws 1991, Chapter 345, is unchanged.

The State Planning Agency shall give to the Department of Administration all contracts, books, maps, plans, papers, records, supplies, and equipment relating to the transferred activities.

Rulemaking authority for the dispute resolution program is transferred to the Department of Administration. All rules adopted by the State Planning Agency pursuant to these duties remain in effect and shall be enforced until amended or repealed in accordance with law by the Department of Administration.

The Department of Administration is the legal successor in all respects of the State Planning Agency in regard to the transferred duties. The bonds, resolutions, contracts, and liabilities of the State Planning Agency become the bonds, resolutions, contracts and liabilities of the Department of Administration.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Administration in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the State Planning Agency.


The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1990, Section 16B.37, subdivision 3.


