REORGANIZATION ORDER NO. 166

Pursuant to Minnesota Statutes 1992, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the Department of Labor and Industry's duties for elevator licensure and inspection (Minnesota Statutes 1992, Section 16B.61, subd. 2, and Sections 183.001 to 183.358) are transferred to the Department of Administration.

Consistent with this transfer of duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Department of Labor and Industry to the Department of Administration:

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1992, Section 43A.18, or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The Department of Labor and Industry shall give to the Department of Administration all contracts, books, maps, plans, papers, records, supplies, and equipment relating to the transferred duties.

Rulemaking authority under Minnesota Statutes 1992, Section 183.358 is transferred to the Department of Administration. All rules adopted by the Department of Labor and Industry pursuant to these duties remain in effect and shall be enforced until amended or repealed in accordance with law by the Department of Administration.

The Department of Administration is the legal successor in all respects of the Department of Labor and Industry in regard to the transferred duties. The bonds, resolutions, contracts, and liabilities of the Department of Labor and Industry become the bonds, resolutions, contracts, and liabilities of the Department of Administration.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Administration in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Department of Labor and Industry.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1992, Section 16B.37, subdivision 3.

In accordance with Minnesota Statutes 1992, Section 16B.37, subdivision 2, this order is effective upon filing with the Secretary of State and shall remain in effect until amended or repealed.


