REORGANIZATION ORDER NO. 175

Pursuant to Minnesota Statutes 1994, section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the duties of the Minnesota State Historical Society for financial and administrative support of the State Archaeologist and duties of personnel employed to assist the State Archaeologist under Minnesota Statutes 1994, section 138.35, as amended by Laws 1996, chapter 452, section 31, are transferred to the Minnesota Department of Administration.

Consistent with this transfer of duties, the following position and its incumbent, with all accrued benefits, are transferred from the Historical Society to the Department of Administration:

Mark Dudzik	State Archaeologist

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1994, section 43A.18, as amended, or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The powers to employ personnel to assist in carrying out the state archaeologist's duties and spend state appropriations to compensate such personnel under Minnesota Statutes 1994, section 138.35, as amended by Laws 1996, chapter 452, section 31, are transferred to the Department of Administration.

The Historical Society shall give to the Department of Administration all contracts, books, maps, plans, papers, records, supplies, and equipment relating to the transferred duties.

The Department of Administration is the legal successor in all respects of the Historical Society in regard to the transferred duties. The bonds, resolutions, contracts, and liabilities of the Historical Society become the bonds, resolutions, contracts, and liabilities of the Department of Administration.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Administration in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Historical Society.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1994, section 16B.37, subdivision 3.

In accordance with Minnesota Statutes 1994, section 16B.37, subdivision 2, this Order is effective upon filing with the Secretary of State and shall remain in effect until amended or superseded.
