REORGANIZATION ORDER NO. 177

Pursuant to Minnesota Statutes 1994, section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the Intergovernmental Information Systems Advisory Council (hereinafter "Council") its powers, duties, and personnel, as established in Minnesota Statutes 1994, section 16B.42, and as amended by Laws 1995, Chapter 254, article 1, section 58, and Laws 1995 First Special Session, Chapter 3, article 16, section 13, are transferred to the Department of Administration.

Consistent with this transfer of powers and duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Council to the Department of Administration:

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 1994, section 43A.18, or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The Council shall give to the Department of Administration all contracts, books, maps, plans, papers, records, supplies, and equipment relating to the transferred activities.

The Department of Administration is the legal successor in all respects of the Council in regard to the transferred activities. The bonds, resolutions, contracts, and liabilities of the Council become the bonds, resolutions, contracts, and liabilities of the Department of Administration.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Administration in the same manner under the same terms and conditions, and with the same

effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Council.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1994, section 16B.37, subdivision 3. Transferred funds include, but are not limited to, those appropriated for development of a local government financial reporting system under Laws 1994, Chapter 587, article 3, section 3.

In accordance with Minnesota Statutes 1994, section 16B.37, subdivision 2, this Order is effective upon filing with the Secretary of State and shall remain in effect until amended or superseded.




