REORGANIZATION ORDER NO. 183

Pursuant to Minnesota Statutes, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency and avoid duplication in the operation of state government, the functions, personnel, powers, responsibilities, and duties of the Department of Children, Families and Learning for the Oil Overcharge, Weatherization, and Energy Assistance Programs, as set forth below, are transferred to the Department of Economic Security. Reorganization Order No. 179, filed with the Secretary of State on July 1, 1997, which transferred these programs from the Department of Economic Security to the Department of Children, Families and Learning, is superseded with respect to the functions, personnel, powers, responsibilities, and duties transferred by this Order.

The following powers and duties of the Department of Children, Families and Learning are transferred to the Department of Economic Security:

Nothing in this order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes, Section 43A.18, or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The Department of Children, Families and Learning shall give to the Department of Economic Security all contracts, books, maps, plans, papers, records, supplies, and equipment relating to the transferred activities.

Rulemaking authority for the Energy Assistance and Weatherization Programs is transferred to the Department of Economic Security. All rules adopted by the Department of Children, Families and Learning pursuant to these duties remain in effect and shall be enforced until amended or repealed in accordance with law by the Department of Economic Security.

The Department of Economic Security is the legal successor in all respects of the Department of Children, Families and Learning in regard to the transferred duties. The bonds, resolutions, contracts, and liabilities of the Department of Children, Families and Learning become the bonds, resolutions, contracts, and liabilities of the Department of Economic Security.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Economic Security in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer from the Department of Children, Families and Learning.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes, Section 16B.37, subdivision 3.

Pursuant to Minnesota Statutes, Section 16B.37, subd. 2, copies of this Order were submitted to the chairs of the Governmental Operations committees in the House of Representatives and the Senate at least 30 days before the Order was filed with the Secretary of the Senate.

In accordance with Minnesota Statutes, Section 16B.37, subdivision 2, this order is effective upon filing with the Secretary of State and shall remain in effect until amended, repealed or superseded.
