REORGANIZATION ORDER NO. 195

Pursuant to Minnesota Statutes 2006, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve the efficiency of state government, the functions, powers, duties and responsibilities of the Department of Administration pertaining to the Management Analysis Division are transferred to the Department of Finance.

The purpose of transferring those functions, powers, duties and responsibilities to the Department of Finance is to more closely align workforce and financial analysis functions within the Department of Finance.

Consistent with the transfer of powers and duties, all affected personnel, with accrued benefits, are transferred to the Department of Finance. Nothing in this Order shall be construed as abrogating or modifying any rights now enjoyed by affected employees under the managerial or commissioner's plan under Minnesota Statutes 2006, Section 43A.18, or the terms of an agreement between an exclusive representative of public employees and the state or one of its appointing authorities.

The Department of Administration will give the Department of Finance all contracts, agreements, books, maps, plans, papers, records, supplies and equipment relating to the transferred activities.

Rulemaking authority of the Department of Administration's Management Analysis Division, if any, is transferred to the Department of Finance. All rules adopted by the Department of Administration pursuant to these transferred functions, powers and duties remain in effect and shall be enforced until amended or repealed in accordance with law by the Department of Finance.

The Department of Finance is the legal successor in all respects of the Management Analysis Division of the Department of Administration. The bonds, resolutions, contracts and liabilities of the Management Analysis Division become the bonds, resolutions, contracts and liabilities of the Department of Finance.


Any proceedings, court actions, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Department of Finance in the same manner under the same terms and conditions and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer from the Department of Administration.

The Commissioner of Finance shall make necessary financial determinations in accordance with Minnesota Statutes 2006, Section 16B.37, Subdivision 3. The unexpended balance of any appropriation to the Department of Administration for the purposes of any powers, functions or duties are reappropriated to the Department of Finance under the same conditions as the original appropriation to the transferring agency.

Pursuant to Minnesota Statutes 2006, Section 16B.37, Subdivision 2, copies of this Order were submitted to the secretary of the senate, the chief clerk of the house, and the chairs of the governmental operations committees in the Minnesota Senate and House of Representatives.


