REORGANIZATION ORDER NO. 56

Pursuant to Minnesota Statutes 1974, Sections 16.25, 16.13, and 16.135, the following administrative reorganization is made.

The state organized crime control unit and its functions are transferred from the office of the attorney general to the department of public safety, bureau of criminal apprehension.

The following classified and unclassified positions and their incumbents with all accrued benefits are transferred to the department of public safety, bureau of criminal apprehension:

The legislative complement of the office of the attorney general is decreased by seven positions and the legislative complement of the department of public safety is increased by seven positions.

The following appropriations are hereby transferred from the office of the attorney general (Laws 1975, Chapter 204, Section 13) to the department of public safety, bureau of criminal apprehension (Laws 1975, Chapter 204, Section 31):

All allotments, requisitions, encumbrances, and the allotted free balances for salaries including fringe benefits, for supplies and expenses, and all personal property assets are transferred from the office of attorney general, organized crime control unit, to the department of public safety, bureau of criminal apprehension as of July 1, 1975.

The commissioner of finance is authorized to complete these transfers and upon their accomplishment notify the commissioner of administration of their values.

Department of Administration Reorganization Order No. 9 is rescinded.
