Further, any Federal monies received by the State Planning Agency for purposes of Crime Prevention and Control, and not obligated on July 1, 1971, are hereby transferred to the Governor's Commission on Crime Prevention and Control. As soon after July 1, 1971 as possible the State Planning Agency shall report these unobligated Federal monies to the Department of Administration with a request to transfer these monies to the Governor's Commission on Crime Prevention and Control.

All obligations made prior to July 1, 1971 shall continue to be controlled by and recorded on the books of account of the State Planning Agency.

This transfer is being initiated to comply with the Governor's Executive Order No. 3, May 27, 1971. This order removes the responsibility for administration of the Governor's Commission on Crime Prevention and Control from the State Planning Agency and gives it a status of being a part of the Governor's executive office.
