AMENDMENT TO
REORGANIZATION ORDER NO. 87

Pursuant to Minnesota Statutes, Section 16.125, the following Amendment to Reorganization Order No. 87 is made with the prior approval of the Governor.

For the 1982-83 biennium, two-thirds of the total annual funding for the County Assistance Forestry Program shall be provided by the Iron Range Resources and Rehabilitation Board, and one-third of the funding shall be provided by the Department of Natural Resources. Funds shall be transferred to the Department of Natural Resources as soon as possible after July 1 of each fiscal year.

This amendment shall expire on June 30, 1983, and nothing herein shall be construed to bind the Iron Range Resources and Rehabilitation Board to funding any portion of this program in future biennia.

All other terms of Reorganization Order No. 87 shall remain unchanged.

Pursuant to Minnesota Statutes, 1977 Supplement, Section 16.125, the following administrative reorganization is made with the prior approval of the Governor.

The duties of the Board and of the Commissioner of Iron Range Resources and Rehabilitation related to forest resource management assistance to the county boards in timber sales, forest development, wildlife habitat improvement, recreational development, management plans, land use, and other forest management activities are transferred to the Department of Natural Resources.

These duties include but are not limited to those prescribed by Minnesota Statutes 1976, Section 298.22, as amended, insofar as the duties relating to the activities listed in the preceding paragraph are undertaken pursuant to Section 298.22, as amended, or those prescribed by Minnesota Statutes 1976, Section 282.38, Subdivisions 1 and 3.

The following budgetary authorized positions, necessary to perform these duties, and their incumbents at their current salary with all accrued benefits are transferred from the Iron Range Resources and Rehabilitation Board to the Department of Natural Resources:

The approved budgetary authorized complement of Iron Range Resources and Rehabilitation (39114:00-20) is decreased by ten positions and the approved budgetary authorized complement of the Department of Natural Resources (31200:14-20) is increased by ten positions.

The annual funding for the salaries and fringe benefits for these positions shall be transferred on July 1 of each fiscal year from the Iron Range Resources and Rehabilitation Board, appropriation account 39114:00-20, to the Department of Natural Resources, appropriation account 31200:14-20. Additional travel and other necessary expenses agreed upon annually between the Iron Range Resources and Rehabilitation Board and the Department of Natural Resources will also be transferred from appropriation account 39114:00-20 to appropriation account 31200:14-20 on July 1 of each fiscal year. The Commissioner of Finance is authorized to complete these transfers and to notify the Commissioners of Administration, Iron Range Resources and Rehabilitation, and Natural Resources when this is actually accomplished.

The forest resource management assistance to county boards activity within the Iron Range Resources and Rehabilitation Board is combined with the forest management activities in the Department of Natural Resources.

This order is effective January 4, 1978. In accordance with Minnesota Statutes, 1977 Supplement, Section 16.125, the order shall be filed with the Secretary of State, on or before January 4, 1978, and shall remain in effect until amended or superseded.
