Beginning at the Northwest corner of Section Thirty-six (36) Township Thirty-nine (39), Range Twenty-five (25); thence South on the Section line 404 feet; thence East 107.25 feet; thence North 404 feet to the Section line; thence West on said Section line 107.25 feet to the place of beginning.
