

ORDINANCE NO. 39

AN ORDINANCE EXTENDING THE BOUNDARY LINES  
OF THE VILLAGE OF KASOTA, LE SUEUR COUNTY,  
MINNESOTA, AND INCLUDING CERTAIN LAND IN  
SAID VILLAGE.

THE VILLAGE COUNCIL OF KASOTA, MINNESOTA <sup>AT</sup> DO ORDAIN AS FOLLOWS:

Section 1. The boundaries of the Village of Kasota are hereby extended to include the following described land:

"Commencing at the point of intersection of the westerly line of State Trunk Highway No. 169 with the east and west center line of Section 33, Township 110, North of Range 26 West, Le Sueur Co., Minnesota, thence running due east along said center line a distance of 1200 feet, running thence due south parallel with the east line of said Section 33 a distance of 160 feet, thence at a right angle west and parallel with said east and west center line a distance of 175 feet, thence due north a distance of 35 feet, thence due west a distance of 1025 feet to the westerly boundary line of said Trunk Highway No. 169, thence due north a distance of 125 feet to the point of beginning, excepting therefrom easement for Highway purposes for Minnesota Trunk Highway No. 169."

Section 2. This Ordinance shall take effect and be in force from and after its passage, publication and the filing of a certified copy thereof with the Secretary of State of the State of Minnesota.
