ORDINANCE NO. 123

AN ORDINANCE ANNEXING THE SPRINGFIELD MUNICIPAL AIRPORT  
TO THE CITY OF SPRINGFIELD, AND EXTENDING THE CORPORATE  
LIMITS OF THE CITY OF SPRINGFIELD, BROWN COUNTY,  
MINNESOTA

THE CITY OF SPRINGFIELD, MINNESOTA, DOES ORDAIN:

SECTION 1. That the Municipal Airport of the City of Springfield, has now been partly developed and improved and should be further developed, improved and retained as a Municipal Airport for said city as soon as proper provision therefor can be made. That said Municipal Airport is reasonably necessary and proper for the City of Springfield to maintain, and that its improvement and maintenance is a proper governmental function for the City of Springfield to engage in under the laws of this State.

SECTION 2. That the premises so owned, improved and designated as the Springfield Municipal Airport is known and described as the North Half (N1/2) of the Northeast Quarter (NE-1/4), of Section Twenty-four (24), Township One Hundred Nine (109), Range Thirty-five (35), Brown County, Minnesota, at this time, but are now located within the Town of North Star, in Brown County, Minnesota. That said premises are free and clear of encumbrances and that there are no public highways over, on or across said premises, and no other persons interested therein, except the inhabitants of the City of Springfield.

SECTION 3. That if the City of Springfield is to exercise the proper police supervision, control and improvement over said airport it is fitting and proper that the same be annexed to and incorporated in the city limits of the City of Springfield, Minnesota, and that said city enjoy the benefits and privileges of said real estate as other public property within said city which it does now enjoy.

SECTION 4. That from and after the adoption and publication of this Ordinance, the Municipal Airport located upon the above described premises be and the same shall hereby be annexed to and incorporated within the limits of said city of Springfield, Minnesota, and that the corporate limits of said city be extended and enlarged to include the above described premises.

This Ordinance shall become effective thirty days after its passage and publication as required by the City Charter.

Passed and adopted at a regular meeting of the City Council upon the second reading thereof, held this 22nd day of August, 1938.
