

ORDINANCE NO. 148

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain  
as follows:

Section 1. Pursuant to a petition duly signed  
by a majority of the owners of all lots in the east  
half of Block Two (2) of Brannon Addition to Staples,  
and all of Block Twenty (20) of O'Connor's Addition  
to Staples, and all the lots in the east half of  
Block One (1) of O'Connor's Addition to Staples,  
which petition has been duly filed in the office  
of the City Clerk of the City of Staples, which  
lands have been platted into lots and blocks and  
which lands abut upon and are adjacent to the City  
of Staples, Todd County, Minnesota, and in which  
petition said petitioners did petition that the  
City Council do and perform all things necessary  
to accomplish the annexation of said premises to and  
within the City of Staples in accordance with the  
provisions of the laws of the State of Minnesota and  
the charter of the City of Staples, and which lands  
and premises are more particularly described as  
follows:

Lots Seven (7) to Twelve (12), both inclusive,  
of Block Two (2) of Brannon Addition to Staples,

and

Lots One (1) to Twelve (12), both inclusive,  
of Block Twenty (20) of O'Connor's Addition to  
Staples,

and

Lot One (1), South Six and one-half Feet (S 6½ ft.)  
of Lot Two (2), North Fifteen Feet (N 15 ft.) of  
Lot Three (3), and all of Lots Four (4), Five (5)  
and Six (6) all in Block One (1) of O'Connor's  
Addition to Staples;

the corporate limits of said City of Staples are  
hereby extended to include the above described lands  
within its limits and the above described lands shall  
hereafter be included within the corporate limits of  
said City of Staples and shall be a part of said City  
of Staples, and shall be governed as other lands and  
territory in said City of Staples are now governed.

Section 2. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this ordinance to the Register of Deeds of Todd County, Minnesota, and to the Secretary of State of the State of Minnesota.

Section 3. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.

The above ordinance was passed at a regular meeting of the City Council of the City of Staples on the 12th day of December, 1950,




