PETITION FOR INCORPORATION OF VILLAGE

To the Board of County Commissioners of the County of Norman, State of Minnesota:

The undersigned electors, residences upon the following described lands, which have been wholly or partly platted into lots and blocks and upon lands adjacent thereto, in the County of Norman, and State of Minnesota, and not in any incorporated Village, which said plat has been duly and legally certified according to the laws of this State and filed in the Office of the Register of Deeds by the County in which said lands or larger portion thereof lie, to-wit:

Beginning at the Southeast corner of Section Twenty-one (21), Township One Hundred Forty-three (143), Range Forty-six (46), thence North 1320 feet, thence West 2168 feet, thence South 2640 feet, thence East 2168 feet, thence North 1320 feet to the point of beginning, -

containing about 110 acres more or less, and that the resident population thereof is one hundred fifty-four (154) persons, hereby petition your Honorable Board to appoint a time and place when and where the electors actually residing upon said lands may vote for or against the incorporation of a Village to be named "Borup".

The number of persons actually residing in said territory are one hundred fifty-four as has been duly ascertained by a census taken under our direction on or about the 20th day of October, 1950, as appears by the verification hereto.




