AN ORDINANCE RELATING TO THE ANNEXATION OF  
CERTAIN TERRITORY TO THE VILLAGE OF  
EXCELSIOR, MINNESOTA

The Village Council of the Village of Excelsior, ordains

SECTION I. ANNEXATION.

That the land hereinafter described in Section II hereof, the council having determined that the annexation thereof is to the best interests of the village and of territory affected, is hereby annexed to and included within the boundaries of the Village of Excelsior pursuant to a petition of the owner of said land and in accordance with M. S. A., Section 412.041, Subdivision 4.

SECTION II. DESCRIPTION OF LAND ANNEXED.

That the land hereby annexed is situated in Hennepin County, Minnesota, and is described as follows, to-wit:

Lot One Hundred Eighty-six (186), Auditor's Subdivision Number 135, Hennepin County, Minnesota, including adjacent one-half of Grove Street vacated, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said Hennepin County.

SECTION III. CERTIFIED COPIES TO BE FILED.

The Clerk is hereby directed to file certified copies of this ordinance in the office of the Auditor of Hennepin County and in the office of the Secretary of State of the State of Minnesota.

SECTION IV. EFFECTIVE DATE.

This ordinance shall take effect and be in force from and after its passage and publication and the filing of said certified copy aforesaid.
