

ORDINANCE NO. 2 4 8

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE CITY OF WORTHINGTON,
MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

WHEREAS, pursuant to Section 413.14, and all amendments thereto,
of the Minnesota Statutes for 1941, all owners of property hereinafter
described and abutting upon the City of Worthington, have petitioned the
City Council of said City of Worthington to have such property annexed to
said City; and

WHEREAS it is desired that said territory become a part of said City
of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared
to be a part of the City of Worthington; to wit,

That part of Government Lots 3 and 4, Section 22, Township 102 North,
Range 40 West of the 5th P.M., County of Nobles and State of Minnesota,
described as follows: Starting at a point 204.6 feet North of the South-
west corner of Lot 37, Block 3, Cherry Point Park in the City of Worthing-
ton, as the point of beginning; thence North on said West line of Cherry
Point Park, a distance of 250 feet; thence West, a distance of 220 feet;
thence South along the West line of Thompson Avenue, a distance of 133
feet; thence in a Westerly and Southerly direction and parallel to the
North line of Lake View Drive, a distance of 1305 feet; thence in a
Southerly and Easterly direction, a distance of 150 feet; thence along the
northerly line of Lake View Drive, a distance of 1467 feet; thence North,
a distance of 32 feet; thence East, a distance of 220 feet to the point of
beginning.
