ORDINANCE NO. 2 5 1

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE CITY OF WORTHINGTON,
MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

WHEREAS, pursuant to Section 413.14, and all amendments thereto, of the Minnesota Statutes for 1941, all owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington, to have such property annexed to said City; and

WHEREAS it is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to wit,

That part of the Southwest Quarter (SW $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section 14, Township 102, Range 40, Nobles County, Minnesota, described as follows: Beginning at a point 546.6 feet East of the South Quarter corner of said Section 14 and on the South line of said section as the place of beginning; thence Northerly a distance of 564 feet; thence Easterly and parallel to the South line of Section 14, a distance of 115 feet, 6 inches; thence Southerly and parallel to the East line of Section 14, a distance of 564 feet to the South line of Section 14; thence Westerly along the South line of Section 14, a distance of 115 feet, 6 inches to the point of beginning; except the Southerly 317 feet thereof which, previously, has been annexed to said City.
