

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE  
OF MADELIA TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES.

SECTION I. A petition has been filed with the governing body of the Village of Madelia, Minnesota by the sole owner of the following described real estate, to have such land included within the Village of Madelia, Minnesota; the legal description of the said land is as follows:

Lots 7 & 8 of Driggers Subdivision of Lot C of the West one-half of the Northwest quarter of Section 26, Township 107, Range 30, excepting therefrom the North 115 feet of said Lot 7 & Lot 8; all of Lot 9 and Lot 10 of Driggers subdivision of Lot C of the West one-half of the Northwest Quarter of Section 26, Township 107, Range 30, excepting therefrom the South 141 feet of said Lot 10; including therein the vacated street running East and West lying south of said Lots 7 & 8 and North of said Lot 9; subject to an easement for highway purposes over the West 20 feet of said Lot 7, Lot 9 and Lot 10.

SECTION II. The quantity embraced within the foregoing description as described is one and two-thirds acres.

SECTION III. The Village Council hereby determines:

1. That the annexation will be to the best interests of the Village of Madelia, Minnesota and of the territory affected;
2. That the territory described herein abuts upon the Village of Madelia and is so conditioned as properly to be subject to village government.

SECTION IV. The corporate limits of the Village of Madelia are hereby extended to include the property described in Section I and the same is hereby annexed to and included in the Village as effectively as if it had originally been a part thereof.

SECTION V. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

SECTION VI. This ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section V.
