

ORDINANCE NUMBER 51

AN ORDINANCE ANNEXING TO THE VILLAGE OF ISANTI, ISANTI COUNTY, MINNESOTA, CERTAIN LANDS OF HOWARD E. CARLSON AND GLADYS M. CARLSON.

WHEREAS, <sup>E.</sup> Howard/Carlson and Gladys M. Carlson, as owners of the following described premises located in Isanti County, Minnesota, to-wit:

The West Twelve Feet (12') of the East Five Hundred Thirty Nine (539') feet of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ), in Section Thirty (30), Township Thirty-Five (35), Range Twenty-three (23), Isanti County, Minnesota,

have petitioned this Council for inclusion of said lands within the Village of Isanti, pursuant to Minnesota Statutes Annotated, Section 412.041, Subdivision 4, as amended,

AND WHEREAS, said petition is in due form and has been executed by all of the owners of said lands,

AND WHEREAS, the inclusion of said lands within the Village of Isanti will be to the best interests of the Village and of the lands affected, described above, the same being adjacent to said Village and properly the subject of Village Government,

NOW THEREFORE, THE VILLAGE COUNCIL OF ISANTI, MINNESOTA DO ORDAIN AS FOLLOWS:

1. That the West Twelve Feet (12') of the East Five Hundred Thirty-nine Feet (539') of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) in Section Thirty (30), Township Thirty-five (35), Range Twenty-three (23), Isanti County, Minnesota, be, and the same is, hereby annexed to, included within and made a part of the Village of Isanti, pursuant to Minnesota Statutes Annotated, Section 412.041, Subdivision 4, as amended.

2. Land embraced therein shall henceforth in all

things be subject to the ordinances, rules and regulations of the Village of Isanti as enacted or in the future to be enacted, and to all of the powers granted to said Village by law.

3. A certified copy of this ordinance shall be filed by the Clerk in the office of the County Auditor, Isanti County, Minnesota, and another certified copy of this Ordinance shall be filed by the Clerk in the Office of the Secretary of State. Thereupon the annexation of the lands herein described shall be complete and the lands shall be a part of the Village of Isanti as effectually as if the same had been originally a part thereof.

Adopted by the Village Council of the Village of Isanti, Minnesota, this 13th day of October, 1959.
