

AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF WINONA TO INCLUDE
CERTAIN UNPLATTED LAND NOT EXCEEDING
TWO HUNDRED ACRES

The City Council of the City of Winona do ordain:

Section 1. A petition has been filed with the governing body of the City of Winona, Minnesota by the sole owner of the following described real estate to have such land included within the City of Winona, Minnesota:

The Southeast Quarter of the Southwest Quarter ($SE\frac{1}{4}$ of $SW\frac{1}{4}$) of Section Twenty-eight (28), Township One Hundred Seven (107) North, Range Seven (7) West of the Fifth Principal Meridian, Winona County, Minnesota,

Also, the North One Half of the Northwest Quarter ($N\frac{1}{2}$ of $NW\frac{1}{4}$) of Section Thirty-three (33), Township One Hundred and Seven (107) North, of Range Seven (7), West of the Fifth Principal Meridian, Winona County, Minnesota,

Also, the Northwest Quarter of the Northeast Quarter ($NW\frac{1}{4}$ of $NE\frac{1}{4}$) of Section Thirty-three (33), Township One Hundred Seven (107) North, Range Seven (7) West of the Fifth Principal Meridian, Winona County, Minnesota,

Also, all of that portion of the Southwest Quarter of the Northeast Quarter ($SW\frac{1}{4}$ of $NE\frac{1}{4}$) of Section Thirty-three (33) Township One Hundred Seven (107) North, Range Seven (7) West of the Fifth Principal Meridian, Winona County, Minnesota, lying between the North line of said forty and the county road which crosses said forty.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is 165 acres, more or less.

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Winona, Minnesota and of the territory affected and that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of Winona, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Winona, Minnesota, as effectually as if it had originally been a part thereof.




