ORDINANCE NO. 484

AN ORDINANCE AMENDING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF FAIRMONT, MINNESOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. - That the petition presented to the City Council of the City of Fairmont, Minnesota, requesting that the property hereinafter described be annexed to the City of Fairmont, Minnesota, has been signed by all the owners of said property and that the same abuts upon the corporate limits of the City of Fairmont, and that said petition is in accordance with M.S.A., Section 413.14 and is in all things sufficient.

Section 2. - That the property set forth in said petition is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

All of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) of Section Nine (9), Township One Hundred Two (102) North, Range Thirty (30), West of the Fifth Principal Meridian; except therefrom the North 25.05 feet of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>), said Section Nine (9); and the West 217 feet of the South 150 feet of the North 174.05 feet of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>), said Section; and the West 367 feet of the South 200 feet of the North 374.05 feet of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) of the Southwest Quarter (SW<sup>1</sup>/<sub>4</sub>) said Section, containing 36.7 acres, more or less,

and that said property be and the same is hereby added to and incorporated within the corporate limits of the City of Fairmont, Minnesota, and is hereby declared to be a part of the City of Fairmont, Minnesota, as effectually as if the same had been originally a part thereof and that the corporate limits be and the same hereby are extended to include said property.

Section 3. - That this ordinance shall be in force and effect from and after its passage and publication as required by law and the City Clerk is hereby directed to file a certified copy of this ordinance in the office of the Register of Deeds for Martin County, Minnesota, in accordance with M.S.A., Section 413.14.
