ORDINANCE NO. 21

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE VILLAGE OF NASSAU TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES

Section 1. A petition has been filed with the governing body of the Village of Nassau, Minnesota, by the sole owner or all of the owners in number of the following described real estate to have such land included within the Village of Nassau, Minnesota:

Commencing at the southwest corner of the platted area of the Village of Nassau, as shown by the plat thereof on file and of record in the office of the Register of Deeds in and for the above county and state, running thence west along the south boundary line of Government Lot Four (4) in Section Thirty-two (32), Township One Hundred Nineteen (119), Range Forty-six (46), to the west line of Government Lot Four (4), in said Section, being also the boundary line between the states of Minnesota and South Dakota, thence north along such west line of Government Lot Four (4) in said section to the north line of the railroad right-of-way in said section, thence in a northeasterly direction along the north line of said railroad right-of-way intersects with the west line of platted area of the Village of Nassau, thence south along the west line of the platted area of the Village of Nassau to the place of beginning.

* to the point where said north line of said railroad right-of-way

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is 15 acres.

Section 3. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village of Nassau, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 4. Therefore, the Village of Nassau, Minnesota, hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the Village of Nassau, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, and from and after its passage and publication.
