

ORDINANCE FOR THE ANNEXATION OF LAND  
PURSUANT TO LAWS 1957, CHAPTER 666,  
SECTION 3, AS AMENDED BY LAWS 1961,  
CHAPTER 649, SECTION 3.

Ordinance No. 10

WHEREAS a Petition signed by a majority in number of the owners of the hereinafter described territory has been filed with the governing body of the Village of Sunfish Lake, Minnesota, seeking the annexation of the following described territory to the Village of Sunfish Lake, to-wit:

That part of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 32, Township 26 North, Range 22 West, of the Fourth Principal Meridian, lying east of the west line of Robert Street (State Trunk Highway No. 3 formerly known as State Trunk Highway No. 210) and lying south of Salen Church Road, excepting and including that part platted as Robert Salen Vista; also, the west 618.75 feet of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section 32 lying south of Salen Church Road; also, the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section 9, Township 27 North, Range 22 West, of the Fourth Principal Meridian; also, that part of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of said Section 9 lying east of the west line of Robert Street (State Trunk Highway No. 3, formerly known as State Trunk Highway No. 210) excepting and including the south 220 foot thereof, all in Sawyer Grove Township, Dakota County, Minnesota, and

WHEREAS said territory:

- (a) does not exceed two hundred (200) acres in area;
- (b) abuts upon said Village of Sunfish Lake;
- (c) is not now included in any municipality; and
- (d) is suitably conditioned for municipal government; and,

WHEREAS, this Council has held a hearing on March 19, 1962, after at least thirty (30) days posted notice, on the annexation proposed and sought by the above petition; and

WHEREAS, this Council has determined that annexation of the above described territory to the Village of Sunfish Lake will be to the best interests of said Village and of the said territory, now, therefore,

**THE VILLAGE COUNCIL OF SUNFISH LAKE ORDAINS:**

**SECTION I**

That the following described territory is declared to be annexed to the Village of Sunfish Lake, Minnesota, to-wit:

That part of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 32, Township 28 North, Range 22 West, of the Fourth Principal Meridian, lying east of the west line of Robert Street (State Trunk Highway No. 3, formerly known as State Trunk Highway No. 218) and lying south of Salem Church Road, excepting and including that part platted as Robert Salem Vista; also, the west 618.75 feet of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section 32 lying south of Salem Church Road; also, the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section 5, Township 27 North, Range 22 West, of the Fourth Principal Meridian; also, that part of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of said Section 5 lying east of the west line of Robert Street (State Trunk Highway No. 3, formerly known as State Trunk Highway No. 218) excepting and including the south 220 feet thereof, all in Inver Grove Township, Dakota County, Minnesota.

**SECTION II**

That the annexation herein provided shall be deemed final upon filing a copy of this Ordinance with the County Auditor for Dakota County, Minnesota, the Minnesota Secretary of State, and the Commission created by laws of Minnesota, 1959, Chapter 636, Section 1, as amended.
