ORDINANCE NO. 556

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITTLE FALLS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES.

The City Council of the City of Little Falls do ordain:

Section 1. A petition has been filed with the governing body of the City of Little Falls, Minnesota, by all of the owners in number of the following described real estate to have such land included within the City of Little Falls, Minnesota:

The SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of section 9, township 40, range 32 except one-half acre along the south line thereof heretofore sold for road purposes and excepting a parcel described as follows: Beginning at the NW corner of said SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of section 9, township 40, range 32, thence go East on the North line thereof for a distance of 26 feet to the point of beginning; Thence continue East on said line for a distance of 203 $\frac{1}{2}$  feet, thence at a right angle South for a distance of 214 feet, thence at a right angle West for a distance of 203 $\frac{1}{2}$  feet, thence North to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description and bounded as described is 38 $\frac{1}{2}$  acres.

Section 3. The City Council hereby determines:

- (1) That the annexation will be to the best interest of the City of Little Falls, Minnesota, and of the territory affected;
- (2) That the territory described herein abuts upon the City of Little Falls and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of Little Falls, Minnesota hereby ordains and declares that the property hereinbefore described be, and the same is hereby annexed to, and included in, the City of Little Falls, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy

thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, and thirty (30) days from and after its passage and publication.
