ORDINANCE NO. 150

An Ordinance Annexing Part of SW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 29, Township 30 North, Range 21 West, in Washington County, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of the land hereinafter described, in Washington County, Minnesota, containing less than two hundred acres, abutting on the Easterly side of the Village of Mahtomedi, requesting the annexation of said land to said Village, said Petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

All that part of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Twenty-nine (29), Township Thirty (30) North, Range Twenty-one (21) West, described as follows:

Beginning at a point in the West line of said tract Fifteen (15) feet Southerly from the Northwest corner thereof, and running thence South on said West line of said tract Two Hundred Sixty-four (264) feet to a point thence East on a line parallel to the North line of said tract, Six Hundred Sixty (660) feet to a point, thence North on a line parallel with the West line of said tract to a point Fifteen (15) feet South of the North line of said tract; thence West to the place of beginning, together with the East Half of Warner Road adjoining the West line of the above described premises.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
