NOTICE OF EXPIRATION OF REDEMPTION.

To St. Louis Bay Land Co.

You are hereby notified that the following piece or parcel of land, situated in the County of St. Louis, State of Minnesota, and known and described as follows, to-wit:-

Northeast one quarter of southwest one quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) except railway Right of Way, Section Fourteen (14), Township Forty-nine (49) North, Range Fifteen (15) West, according to the Government survey thereof is now assessed in your name.

That at a tax judgment sale held on the 12th day of May, A.D., 1913, which sale was held pursuant to the real estate tax judgment duly given, and made in and by the District Court in and for said County of St. Louis, on the 26th day of March, A.D., 1913, in proceedings to enforce the payment of taxes delinquent upon real estate for the year A.D. 1911 for said County of St. Louis, the above described piece or parcel of land was sold for the sum of \$33.28.

That the certificate of sale for said piece or parcel of land executed and delivered by the auditor of said county for said sale has been presented to me by the holder thereof for the purpose of having notice of expiration of time for redemption from said tax sale of said property given and served; and that the amount required to redeem said piece or parcel of land exclusive of the costs to accrue upon this notice is the sum of \$33.28, and interest at the rate of 12 per cent per annum from said 12th day of May, 1913, to the day such redemption is made.

And the further sum of 28.88 being the amount of the delinquent taxes for the year 1913 upon said premises, which were heretofore paid by the holder of said tax certificate, together with interest on said last named amount at the rate of 12 per cent per annum from the 4th day of February, A.D., 1914, until the day such redemption is made.

And the further sum of \$23.81 being the amount of the delinquent taxes for the year 1913 upon said premises, which were heretofore paid by the holder of said tax certificate, together with interest on said last named amount at the rate of 12 per cent per annum from the 21st day of January, A.D., 1915, until the day such redemption is made.

And the further sum of \$23.72 being the amount of the delinquent taxes for the year 1914 upon said premises, which were heretofore paid by the holder of said tax certificate, together with interest on said last named

amount at the rate of 12 per cent per annua from the 11th day of January, A.D. 1916, until the day such redemption is made.

The time for redemption of said piece or parcel of land from said tax sale will expire sixty (60) days after the service of this notice, and the filing of proof of such service in my office.
