ORDINANCE NO. 150

AN ORDINANCE ANNEXING THE FOLLOWING DESCRIBED LAND TO THE VILLAGE OF DILWORTH: ALL OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION TWO, TOWNSHIP ONE HUNDRED THIRTY-NINE, RANGE FORTY-EIGHT, LESS THAT PORTION WHICH IS WITHIN THE EXISTING LIMITS OF THE VILLAGE OF DILWORTH, CLAY COUNTY, MINNESOTA.

BE IT ORDAINED, By the Village Council of the Village of Dilworth, as follows:

Section 1. That Peter Houge and Margit Houge, his wife, are the record owners in fee simple of the real estate hereinafter described and Raymond Welle and Dorothy Welle, his wife; and Garman R. Sampson and Kathleen R. Sampson, his wife; are purchasers of a portion of said land under contract for deed; the land of which the aforesaid persons are the owners of or have an interest in, and which land is unimproved land and abuts against the village on the north, said land described as follows:

All of the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Two (2), Township One Hundred Thirty-nine (139), Range Forty-eight (48), LESS that portion which is within the existing limits of the Village of Dilworth, Clay County, Minnesota, said tract of land consisting of thirty-five (35) acres, more or less.

Section 2. That the Village Council did by resolution dated October 14, 1963 accept for filing a petition to annex said land and notice was given and all proceedings required by Chapter 414, Minnesota Statutes, have been complied with with reference to annexing said land to the Village of Dilworth.

Section 3. That the above-described land is hereby annexed to the Village of Dilworth and the same declared to be an addition to and a part of the said Village of Dilworth, Clay County, Minnesota.

Section 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.


To the Above Addressees:
