
RECOMMENDATION

I, Morris Hursh, Commissioner of Public Welfare, successor to the Director of the Division of Public Institutions, do hereby recommend that the following described property be quitclaimed by the State of Minnesota to the City of Owatonna, State of Minnesota, pursuant to Laws of Minnesota 1953, Chapter 635:

All the tract or parcel of land lying and being in the County of Steele, State of Minnesota, described as follows, to-wit:


That part of Lots 3 and 4 in the North Half of the Northwest quarter of the Northeast quarter of Section 9, Township 107 North, Range 20 West, to-wit: commencing at a point 33 feet north and 286.26 feet west of the Southeast corner of said Lot 3, thence north 618.08 feet to the north line of said section 9, thence west on said north line of said section 9 for 140.96 feet, thence south to the north line of North Street, thence east on said north line of North Street 140.96 feet to the place of beginning, which lies southerly of a line parallel with and distance 175 feet southerly of the following line; beginning at the Northwest corner of the Northeast quarter of the Northwest quarter of Section 9, Township 107 North, Range 20 West, easterly along the north line of said Section 9, 622.7 feet, deflect to right on a 100' curve, delta angle $4^{\circ}24'$, thence on a tangent to said curve 1,631.2 feet.

THIS INDENTURE, Made this 24th day of November, 1964, between State of Minnesota, party of the first part, and City of Owatonna a Municipal Corporation, of the State of Minnesota, party of the second part.

WITNESSETH, That the said party of the first part, pursuant to Chapter 635 of Session Laws of 1953, and upon recommendation of the Commissioner of Welfare, formerly director of the division of public institutions, does hereby Grant, Bargain, Quitclaim and Convey unto the said party of the second part, its successors and assigns, Forever, all the tract or parcel of land lying and being in the County of Steele, and State of Minnesota, described as follows, to-wit:

That part of Lots 3 and 4 in the North Half of the Northwest quarter of the Northeast quarter of Section 9, Township 107 North, Range 20 West, to-wit: commencing at a point 33 feet north and 286.26 feet west of the Southeast corner of said Lot 3, thence north 618.08 feet to the north line of said section 9, thence west on said north line of said section 9 for 140.96 feet, thence south to the north line of North Street, thence east on said north line of North Street 140.96 feet to the place of beginning, which lies southerly of a line parallel with and distance 175 feet southerly of the following line; beginning at the Northwest corner of the Northeast quarter of the Northwest quarter of Section 9, Township 107 North, Range 20 West, easterly along the north line of said Section 9, 622.7 feet, deflect to right on a 100' curve, delta angle 4⁰24', thence on a tangent to said curve 1,631.2 feet.

Excepting from this deed and forever reserving unto the party of the first part, and its assigns, for its and their own use, all right, title, and interest in and to any iron, coal, copper, gold, or other valuable minerals and all water power in or upon said land.

TO HAVE AND TO HOLD THE SAME, Together with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining, to the said party of the second part, its successors and assigns, Forever.

IN TESTIMONY WHEREOF, by the authority aforesaid, this deed is executed in the name of the State of Minnesota by the Governor thereof, and the Great Seal of the State of Minnesota is affixed by the Secretary of State this 24th day of November, 1964
