ORDINANCE NO. 93

AN ORDINANCE ANNEKING THE $W\frac{1}{2}$ OF $E\frac{1}{2}$, SECTION 32, TOWNSHIP 58, RANGE 17
AND A PORTION OF $SE\frac{1}{4}$ OF $NW\frac{1}{4}$, SECTION 29, TOWNSHIP 58 NORTH, RANGE 17 WEST

The City Council of the City of Eveleth do hereby ordain, as follows:

The Southeast quarter of the Northwest quarter
($SE\frac{1}{4}$ of $NW\frac{1}{4}$) of Section Twenty-nine (29) in
Township Fifty-eight (58) North, Range Seventeen
(17) West of the Fourth Principal Meridian,
according to the United States Government survey
thereof, EXCEPTING the following described part
thereof, to-wit:

Beginning at the Southeast corner of said
Northwest quarter ($SE\frac{1}{4}$ of $NW\frac{1}{4}$) and going
North $89^{\circ} 24' 30''$ West along the quarter
line for a distance of 444.88 feet to the
point of beginning; thence going North 89°
 $24' 30''$ West along the quarter line for a
distance of 250 feet to the State Highway
No. 53 right of way line; thence going in
a Northerly direction along said Highway
No. 53 right of way line for a distance of
300 feet; thence going South $89^{\circ} 24' 30''$
East for a distance of 250 feet; thence
going Southerly for a distance of 300 feet
to the point of beginning.

The West half of the East half ($W\frac{1}{2}$ of $E\frac{1}{2}$)
of Section Thirty-two (32) in Township
Fifty-eight (58) North, Range Seventeen (17)
West of the Fourth Principal Meridian, according
to the United States Government survey thereof,

shall be and it hereby is declared to be an addition to the
City of Eveleth and shall become part of the City of Eveleth
as effectively as if it had been originally a part thereof.
