

ORDINANCE NO. 209, NEW SERIES

AN ORDINANCE ANNEXING REAL PROPERTY TO THE CITY
OF BLUE EARTH

BE IT ORDAINED By the City Council of the City of Blue Earth,
as follows:

Section 1. It is recited that the City of Blue Earth, a municipal corporation, has heretofore acquired by purchase for governmental purposes real estate located in the County of Faribault and State of Minnesota more fully described as follows: to-wit:


A tract commencing at the Northeast Corner of the Northwest Quarter of the Northeast Quarter of Section Eighteen (18), Township One Hundred Two (102) North of Range Twenty-seven (27) West of the Fifth Principal Meridian, Faribault County, Minnesota, running thence West 80 rods, thence South 30 rods, thence East 80 rods, thence North 30 rods to point of beginning, excepting all that part thereof lying West of the center of the Blue Earth River.

Section 2. It is hereby determined that it is in the best interest of said City of Blue Earth that said real estate hereinbefore described be annexed to said city pursuant to the status in that case made and provided.

Section 3. It is hereby declared that said tract of land described in paragraph 1 above be and the same hereby is annexed to the City of Blue Earth, a municipal corporation, Faribault County, Minnesota.


Section 4. This Ordinance shall be in force and effect after its passage and publication as required by law.


