
Dear Mr. Lee:

1.22 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE, MINNESOTA.

The Common Council of the City of Pipestone do ordain as follows;

Section 1. The land, described by metes and bounds as follows, to-wit: Commencing at a point 1033 feet west and 450 feet north of the southeast corner of the southeast quarter (SE $\frac{1}{4}$ ) of Section Eleven (11), Township one hundred six (106), Range Forty-six (46) Pipestone County, Minnesota; running thence west, parallel to the south line of said Section a distance of 262 feet to a point; running thence north a distance of 150 feet to a point; running thence east, parallel to the south line of said Section a distance of 262 feet to a point; running thence south a distance of 150 feet to the point of beginning, all in the County of Pipestone and State of Minnesota; now owned by Frank E. Boyd and Carol W. Boyd and being contiguous to and abutting on the corporated limits of said City, is hereby declared to be a part of the City of Pipestone. This annexation is in accordance with the petition of the owners thereof, the Charter of the City of Pipestone and the Minnesota Statutes Annotated Section 414.03 Sub-division 2.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication.
