ORDINANCE NO. 325

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ADJUTING UPON THE LIMITS OF THE CITY.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough; and

WHEREAS, said territory abuts upon the corporate limits of the City of Marshall at the northerly boundary thereof, and is deemed to be urban in character; and

WHEREAS, said territory is owned in fee by said City;

The Common Council of the City of Marshall do ordain as follows:

Section 1, Territory Annexed. The corporate limits of the City of Marshall are hereby extended to include the unplatted property located in the County of Lyon, State of Minnesota, and described as follows now owned by said City:

Also all that part of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section 8, Township 111 North, Range 41 West described as follows: Commencing at West quarter corner of said Section 8, thence North 00 degrees 12 minutes along West section line of said Section 8, twenty (20) feet to point of beginning; thence North 00 degrees 12 minutes West along West section line of said Section 8, Eleven Hundred Seventy-seven and Nine Tenths (1177.9) feet, thence east Four Hundred Fifty (450) feet, thence North 45 degrees, 00 minutes East Five Hundred Ten (510) feet, thence North to a point on the Southeasterly right-of-way line of the Walker and Sioux Falls Railroad, thence North-easterly along said right-of-way line, to a point on the North and South Sixteenth line of the Northwest Quarter (NW $\frac{1}{4}$ ) of said Section 8, thence South along said Sixteenth line Nine Hundred Sixty (960) feet, thence right 3 degrees, 06 minutes, thence right on a curve of Eleven Hundred Ninety and Sixty-nine One Hundredths (1190.69) foot radius for a distance of Eight Hundred Twenty and Seventeen One Hundredths (820.17) feet, thence South 59 degrees, 01 minutes East Two Hundred Forty-five (245) feet, thence South Twenty-five (25) feet, more or less, to a point on the center line of the Redwood River, thence westerly upstream on center line of the Redwood River to a point Five Hundred Seventy and Ninety-seven One Hundredths (570.97) feet North and Eight Hundred Ninety-two and Forty-two One Hundredths (892.42) feet East of the West quarter corner of said Section 8, thence South 12 degrees, 00 minutes West Ninety (90) feet, thence North 83 degrees, 13 minutes West Two Hundred Eleven and Five Tenths (211.5) feet, thence South 02 degrees 56 minutes East Two Hundred (200) feet, thence South 07 degrees 36 minutes West One Hundred Ninety-one (191) feet, thence South 23 degrees, 00 minutes West, One Hundred Fifty (150) feet, thence South 69 degrees, 00 minutes West Four Hundred Thirty (430) feet to point of beginning. (Containing 36.79 acres less .81 acres in County Road (7 right-of-way).

Section 2, Filing. The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Lyon County, State of Minnesota, and the Minnesota Municipal Commission.

Section 3, Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
