Dear Mr. Secretary:

A land identification problem exists in the Superior National Forest in Sections 4, 5, 7, 8, 9, 17, 18, 19 and 20, Township 58 North, Range 10 West, Lake County, Minnesota. It involves a tract which we consider as erroneously omitted from the original Government Survey. Title to this land is uncertain because it cannot be described by reference to the original survey plat on which the area in question is shown as open water of Greenwood Lake.

The enclosed sketch illustrates the problem. It shows the record meander line as it is represented on the original survey plat made in 1894 and an extension survey of Lot 7, Section 18, made in 1933, which is the basis of existing deed descriptions. The same area as it actually exists on the ground is shown for comparison purposes. This detail was drawn from 1948 aerial photographs.

We plan to submit an application to the U. S. Department of Interior, Bureau of Land Management, for an extension survey to include this land. The procedure for making application for such surveys is set forth in Federal Regulations 43 C.F.R. 280.5 to 280.10. Part 230.6 of these regulations requires that applications include proof that notice of intention to apply for such surveys has been served on adjacent landowners, and the Attorney General and the Secretary of State for the State in which the land is located, at least 30 days in advance of the date of the application.

The purpose of this letter is to serve as our notice to you of intent to apply for a survey as required by C.F.R. 280.6. A similar letter is being mailed to the Attorney General of the State of Minnesota and the Commissioner of Conservation, Minnesota. If you have reason to object to this proposed survey, you should file your objection with the Director, Bureau of Land Management, U. S. Department of Interior, Washington, D. C. 20240.


