STATE OF MINNESOTA PATENT

THE STATE OF MINNESOTA to all to whom these presents shall come,
Greeting:

WHEREAS the land hereinafter described was sold as provided by Minnesota Statutes Section 94.09 et seq. and on the 30th day of March A. D. 1967 full payment made to the State therefor, by Luvern W. Rauschke and Charlotte E. Rauschke, who according to Law are now entitled to a conveyance of said land from the State:

NOW, THEREFORE, in consideration of the premises and pursuant to the statutes in such case made and provided, the State of Minnesota does hereby grant, bargain, sell, and convey unto the said Luvern W. Rauschke and Charlotte E. Rauschke, husband and wife, as joint tenants and not tenants in common, their successors and assigns forever, reserving however, all the minerals, mineral substances and oils of every sort pursuant to Minnesota Statutes 94.14, the following described land situated in the County of Hennepin in said State, to-wit:

Lot twenty-nine (29), Block fifteen (15), Palmer's Addition to Minneapolis, according to a plat thereof on file and of record in the office of the Register of Deeds in and for said County of Hennepin and State of Minnesota, said property also is known as 3605 - 28th Avenue, South, Minneapolis, Minnesota. Said premises to be available for possession by the purchaser on or before June 30, 1967.

TO HAVE AND TO HOLD the same unto the said Luvern W. Rauschke and Charlotte E. Rauschke, as joint tenants and not tenants in common, their successors and assigns, forever.

IN TESTIMONY WHEREOF, I Harold Levander as Governor of the State of Minnesota, have caused these letters to be made patent and the great seal of said State to be affixed hereto in the City of St. Paul, this 27th day of June in the year of our Lord one thousand nine hundred and sixty seven.

I hereby certify that full consideration has been paid in accordance with law for the herein described lands and that all taxes due on said lands have been paid.
