
Dear Mr. Schmidt:

ORDINANCE NO. 285

BEING AN ORDINANCE RELATING TO THE ANNEXATION TO THE CITY OF LE SUEUR OF CERTAIN LANDS SITUATED IN RURAL OTTAWA TOWNSHIP, LE SUEUR COUNTY, MINNESOTA.

The Common Council of the City of Le Sueur do ordain:

SECTION I: That pursuant to the provisions of Minnesota Statutes Annotated, Section 414.03, Subdivision 2, the following described lands are hereby annexed by the City of Le Sueur and shall henceforth be included within and be a part of the corporate limits of the City of Le Sueur, Minnesota, to-wit:

That part of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Two (2), Township One Hundred Eleven North (111N), Range Twenty-six West (26W), described as follows: Beginning at the Northeast corner of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of said Section Two (2); thence South along the East line of said tract 990 feet; thence West at right angles 849 feet; thence Northeasterly on a straight line to a point on the North line of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of said Section Two (2), said point being 295 feet West of the place of beginning; thence East along the North line of said tract 295 feet to the place of beginning, and also,

Beginning at the center of Section Two (2), Township One Hundred Eleven North (111N), Range Twenty-six West (26W), Le Sueur County, Minnesota; thence West along the South line of the Southeast Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of said Section Two (2) to the Easterly line of Le Sueur County Road No. 109, commonly known as the Ottawa Road; thence Northeasterly along the Easterly line of said road to its intersection with the North-South centerline of said Section Two (2); thence South along the North-South centerline of said Section Two (2) to the place of beginning. All of said lands lying and being in the County of Le Sueur and State of Minnesota.

SECTION II: All ordinances and portions of ordinances inconsistent herewith are hereby repealed.

SECTION III: This Ordinance shall be in force and take effect from and after its passage and publication, and after filing copies hereof with the Minnesota Municipal Commission, the Le Sueur County Auditor, and the Minnesota Secretary of State, and after compliance with any and all other provisions of applicable law.
