ORDINANCE 57

An Ordinance extending the corporate limits of the Village of Medford, Medford, Minnesota, to include unplatted land not exceeding 200 acres in area abutting upon the village limits.

WHEREAS, a certain petition dated the 1st day of May, 1963, requesting annexation of the territory hereinafter described was duly presented to the Council of the Village of Medford, on the 6th day of May, 1963; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than 200 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by the sole owner of the lands described herein; and

WHEREAS, no objections to the annexation have been received from the town board or the county board; and that the lands do not abut upon the boundaries of any other municipality; and

WHEREAS, the land described in the petition abuts upon the Medford village limits at the westerly boundary thereof;

The Council of the Village of Medford, Minnesota, Ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough;

Section 2. Territory Annexed. The corporate limits of the Village of Medford are hereby extended to include the unplatted land described in the exhibit attached hereto and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof;

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission,

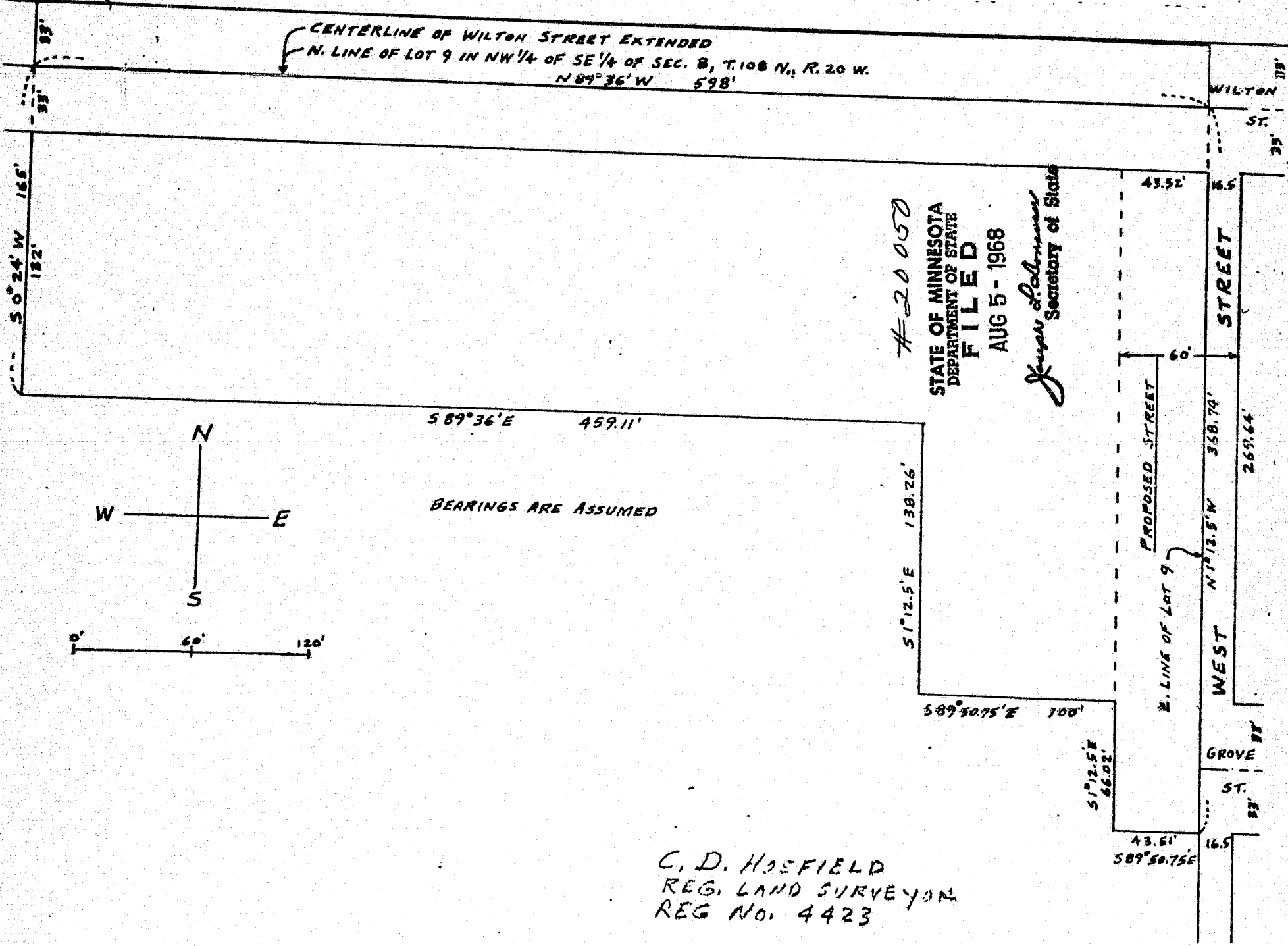

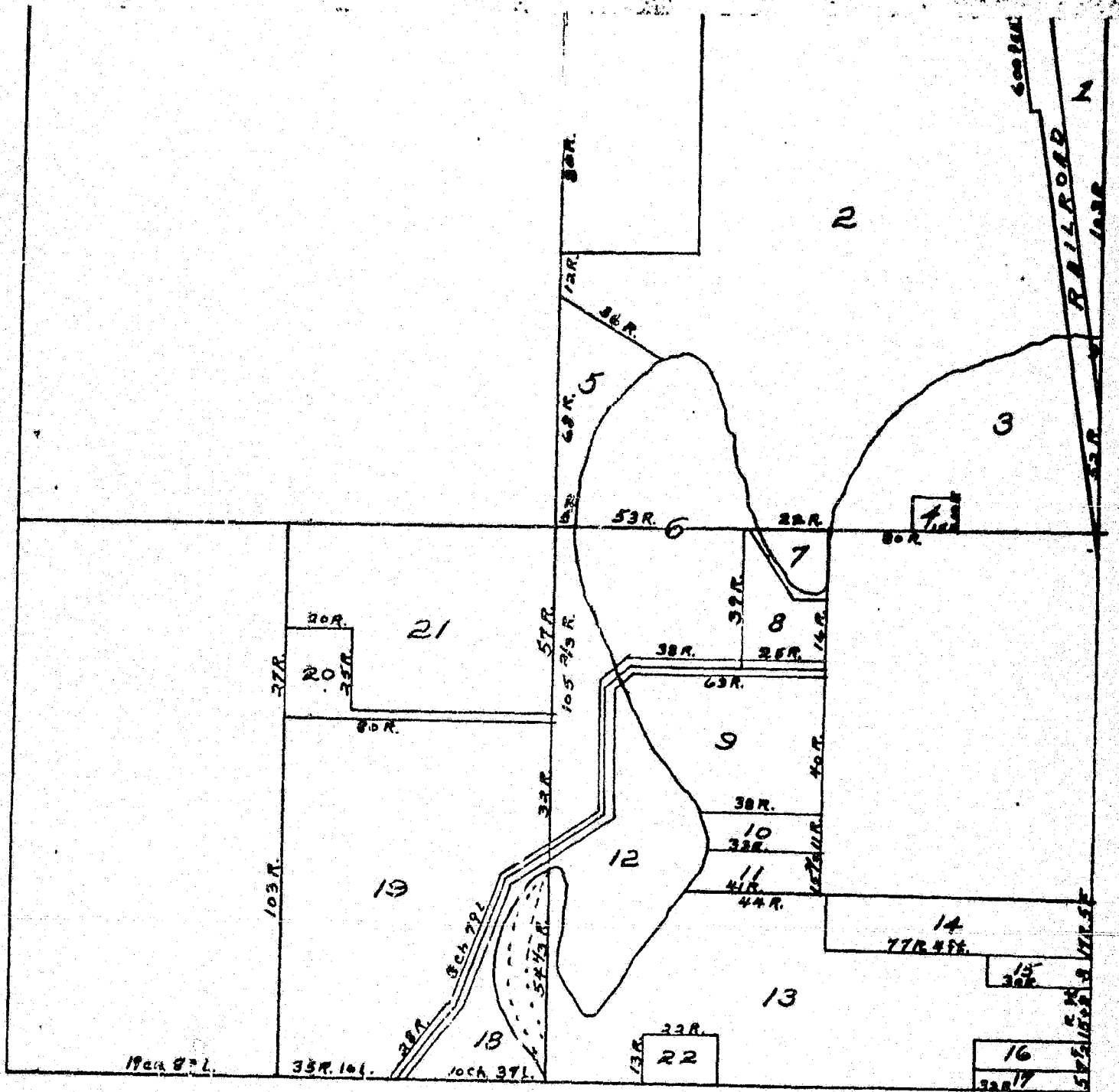
