ORDINANCE NO. 181

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF JACKSON TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJUTING UPON THE CITY LIMITS.

WHEREAS, Certain petitioners dated December 14, 1967, and September 3, 1968, requesting annexation of the Territory hereinafter described were duly presented to the Common Council of the City of Jackson on the 16th day of December, 1967, and the 16th day of September, 1968, respectively; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 10.5 acres of unplatted land no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petitions were signed by all the owners of said land; and

WHEREAS, no objections to the annexation have been received from the town board or the county board; and

WHEREAS, the land described in the petition abuts upon the city limits at the northern boundary thereof; and

WHEREAS, said petitions were filed with the Municipal Commission, State of Minnesota, on the 11th day of September, 1968;

NOW THEREFORE, The Common Council of the City of Jackson, State of Minnesota, do ordain as follows:

Section 1. The city council hereby determines:

1. That the annexation will be to the best interests of the city and to the territory affected.
2. That the territory described herein abuts upon the city limits, and is, or about to become, urban or suburban in character.
3. That none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory annexed:

The corporate limits of the City of Jackson are hereby extended to include the unplatted land, described as follows and the same is hereby annexed to and included within the city as effectually as if it had been a part thereof;

1. A tract of land in the Northeast Quarter of the Southeast Quarter ($NE\frac{1}{4}SE\frac{1}{4}$) and the Southeast Quarter of the of the Northeast Quarter ($SE\frac{1}{4}NE\frac{1}{4}$) of Section Fourteen (14), Township One Hundred Two (102) North, Range Thirty-five (35) West of the Fifth (5th) Principal Meridian, in Jackson County, Minnesota, bounded by the following described lines:

Beginning at the intersection of the North Right-of-Way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company, and the West Right-of-Way line of United States Trunk Highway No. 16 and 71; thence Northerly and Easterly, along said Highway Right-of-Way line, a distance of One Thousand One Hundred (1,100.00) feet, to a point One


Thousand Nine Hundred Eighty-four and Ten-Hundredths (1,984.10) feet South and One Hundred Eighty-three and Thirteen-Hundredths (183.13) feet West of the Northeast corner of said Section Fourteen (14); thence West, on a line at right angles to said East Section Line, a distance of Four Hundred (400.00) feet; thence Southerly and Westerly a distance of One Thousand One Hundred Ninety-nine and Eighty-one Hundredths (1,199.81) feet to a point on the North Right-of-Way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company located Four Hundred (400.00) feet Southerly and Westerly of the intersection of the North Right-of-Way line of Chicago, Milwaukee, St. Paul and Pacific Railroad Company, and the West Right-of-Way line of United States Trunk Highway No. 16 and 71; thence Easterly and Northerly along said Railroad Right-of-Way line a distance of Four Hundred (400.00) feet to the point of beginning.


2. Commencing at a point on the North right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company, that is, 400 feet Southerly and Westerly from the intersection of said right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company, and the West right-of-way line of U. S. Trunk Highways 16 and 71; thence Northeasterly along said north right-of-way line a distance of 150 feet, thence southeasterly at right angles to said north right-of-way line a distance of 100 feet, more or less, to the south right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad Company, thence Southwesterly along said south right-of-way line a distance of 150 feet, thence northwesterly at right angles to said south right-of-way line a distance of 100 feet, more or less, to the place of commencement.
3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.
4. This ordinance shall take effect upon its passage and publication and the filing of certified copies as directed in Section 3.

First reading had October 15th, second reading had November 5th, third reading had and duly passed, adopted and approved this 19th day of November, 1968.
