Ordinance Number One Hundred Forty-five (145)

An Ordinance extending the corporate limits of the City of Canby to include certain unplatted land owned by the City of Canby.

Section 1. The City of Canby is the sole owner of the following tract of land which is located outside the corporate limits of the City of Canby and which is described as follows, to-wit:

That tract in the Northwest Quarter (NW $\frac{1}{4}$) of Section Ten (10), Township One Hundred Fourteen (114), Range Forty-five (45), described as follows, to-wit: Commencing at the NW corner of Section 10, thence South on the West line of said Section 10, a distance of 330 feet; thence running North 89 degrees 34 minutes East a distance of 834 feet; thence running directly North a distance of 330 feet; more or less, to the North line of said Section 10; thence running West along the North line of said Section 10, 834 feet, more or less, to the point of beginning, subject to any easements or conveyances of record whereby any part of said tract has been condemned, taken or otherwise acquired by the State of Minnesota or any other governmental unit or body politic for road or highway purposes.

Section 2. The City Council hereby determines (1) that the annexation will be to the best interest of the City of Canby, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.

Section 3. The corporate limits of the City are hereby extended to include the property described in Section 1. and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.

Section 4. The City Administrative Assistant is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

Section 5. This Ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
