1969, and


WHEREAS, such death has created a vacancy in the office of

WHEREAS, Peter J. Gillen is presently the Chief Deputy
Clerk of District Court for Ramsey County, Minnesota

NOW, THEREFORE, the undersigned, Senior Judge of District
Court, in and for the Second Judicial District, County of Ramsey
and State of Minnesota, pursuant to Minnesota Statutes 485.12,
does hereby temporarily appoint Peter J. Gillen, Chief Deputy
Clerk, as the acting Clerk of the District Court for Ramsey
County, Minnesota, from the date hereof to and including
September 30, 1969. This order is effective immediately and
shall continue through September 30, 1969, and until his successor
qualifies according to law. Before the said Peter J. Gillen,
acting Clerk of District Court, shall assume the duties as such
acting Clerk of the District Court he shall give the bond and
take the oath required by law.

IT IS HEREBY ORDERED, that said Peter J. Gillen, shall
retain his position as Chief Deputy Clerk of District Court for
Ramsey County, Minnesota while so serving as acting Clerk of
said District Court and shall continue to receive the salary
presently being paid to him as such Chief Deputy Clerk.






