ORDINANCE NO. 1159

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a Petition was filed requesting the annexation of the territory hereinafter described, which Petition was duly presented to the Common Council on the 21st day of April, 1969, and

WHEREAS, the quantity of lands embraced within the area described in the Petition and bounded as described is 2.85 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Petition was signed by all the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City of Austin at the South Boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1) The City Council hereby determines, 1) That the annexation will be to the best interests of the City and of the territory affected, 2) that the territory described herein abuts the City limits, and is about to become urban or suburban in character, and 3) that none of said territory is now included within the limits of any City, village or borough.

SECTION 2) The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City of Austin as effectually as if it had originally been a part thereof:

The following described portion of Outlot Five, (5), in the Northeast Quarter of Section Nine, (9), in Township 102, North, of Range 18 West, in Mower County, Minnesota; Beginning at a point on the South line of Southlawn Third Addition to the City of Austin, Minnesota, that is 357 feet West of the Southeast corner of Sub-Outlot One, (1), in said Addition; thence South at right angles to said line, to the North bank of Turtle Creek; thence North-easterly along the north bank of said Turtle Creek as it winds and flows to a point, where said Turtle Creek intersects the South line of Southlawn Third Addition; thence Westerly along said South line of Southlawn Third Addition, to the place of beginning, all in Mower County, Minnesota.

SECTION 3) The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4) The Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
