

PETITION FOR ANNEXATION

To the Honorable Village Council of the Village of Watertown:

We, the undersigned Petitioners, hereby respectfully represent  
and state:

That the undersigned Petitioners desire and request that  
Certain lands be annexed to the Village of Watertown, Carver County,  
Minnesota, and included within its corporate limits, said lands being  
more particularly described as follows, to-wit:

The South 15 acres of the Northeast Quarter of the  
Northwest Quarter (NE<sup>1</sup>/<sub>4</sub> of NW<sup>1</sup>/<sub>4</sub>) Section 9, Township  
117, Range 25, described as follows: Beginning at a  
point 80 rods North of the center of said Section 9 and  
running thence West 80 rods on the Quarter, Quarter  
Section line; thence North 80 rods; thence East 80 rods;  
thence South 80 rods to the place of beginning;  
EXCEPTING, however, from said South 15 acres the  
following described tract, to-wit: That part of the East  
256 feet of the South 15 acres of the Northeast Quarter  
of the Northwest Quarter of Section 9, Township 117  
North, Range 25 West of the fifth principal meridian,  
lying Northerly of "Line A" and "Line B", said lines  
being described as follows: Commencing at the most  
Southerly corner of Outlot 69, The Village of Watertown,  
Carver County, Minnesota; thence Southwesterly along the  
Southwesterly extension of the Southwesterly line of said  
outlot 69 to the Southwesterly right-of-way line of High  
Street as dedicated in the plat of said Village of Watertown;  
thence Northwesterly along said Southwesterly right-of-way  
line a distance of 370.3 feet; thence deflecting left 90°03'  
to a point on the East line of said Northeast Quarter of the  
Northwest Quarter, said point being the point of beginning  
of said "Line A"; thence continuing Southwesterly to the  
end of said "Line A" and the point of beginning of said  
"Line B" at the point of intersection with a line drawn West  
perpendicular to said East line at a point on said East  
line distant 300 feet South of the point of intersection of  
said East line with said Southwesterly right-of-way line;  
thence West along the Westerly extension of said perpendicular  
line so drawn, to the West line of said East 256 feet, and said  
"Line B" there ending.
