ORDINANCE NO. 195

An Ordinance annexing a part of the East Half (E 1/2) and part of the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section Twenty-nine (29), Township Thirty (30) North, Range Twenty-one (21) West of the Fourth Meridian, in Washington County, to the Village of Mahtomedi, Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to those certain petitions signed by all of the owners of the lands hereinafter described in Washington County, Minnesota, containing less than two hundred acres, abutting on the Easterly border of the Village of Mahtomedi, requesting the annexation of said lands to said Village, said petitions having been duly filed with the Clerk of said Village, and it appearing that such annexation will be to the best interests of the Village and of the territories affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said lands described as follows:

That part of the East Half of the Northwest Quarter of the Northeast Quarter (E 1/2 of NW 1/4 of NE 1/4) of Section Twenty-nine (29) in Township Thirty (30) North of Range Twenty-one (21) West of the Fourth Meridian, described as follows:

Commencing at a point in the north line of said Section Twenty-nine (29) located Six Hundred Fifty-eight and Six Hundredths (658.06) feet east of the north quarter (1/4) corner of said Section, the Point of Beginning of the property to be described; thence south along the easterly line of Lakeview Subdivision a distance of Six Hundred Seventy-six and Twenty-three Hundredths (676.23) to a point; thence easterly parallel to said northerly line of said Section a distance of One Hundred Sixty-eight and Nine Tenths (168.9) feet to a point; thence north parallel to the easterly line of said Lakeview Subdivision a distance of Six Hundred Seventy-six and Twenty-three Hundredths (676.23) feet to a point in the north line of said Section; thence westerly along said north line a distance of One Hundred Sixty-eight and Nine Tenths (168.9) feet to the point of Beginning.

and

That part of the SW 1/4 of the NW 1/4 of the NE 1/4 of Sec. 29, Township 30 North, Range 21 West described as follows:

Commencing at a point in the West line of said SW 1/4, NW 1/4, NE 1/4 located 245.34 feet North of the Southwest corner of said SW 1/4, NW 1/4, NE 1/4; thence South along said line a distance of 245.34 feet to said Southwest corner; thence East


along the South line of said SW 1/4, NW 1/4, NE 1/4, a distance of 172 feet to a point; thence North on a line parallel to said West line a distance of 246.6 feet to a point; thence West 172 feet to the Point of Beginning.

and that said described territories are hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.


