AFFIDAVIT OF PUBLICATION

Merlin D. Thompson, being duly sworn, on oath says that he is, and during all the times herein stated has been

the publisher of the newspaper known as the Tyler Journal Herald, and has full knowledge of the facts hereinafter stated; that for more than one year prior to the publication therein of the Ordinance No. 50

hereinafter described, said newspaper was printed and published in the Village of Tyler, in the County of Lincoln, and State of Minnesota, on Wednesday of each week;

That during all said time said newspaper has been printed in the English language from its known office of publication within the Village from which it purports to be issued as above stated and in newspaper format and in column and sheet form equivalent in space to at least 250 running inches of single column, two inches wide;

Has been circulated in and near its said place of publication to the extent of at least two hundred forty (240) copies regularly delivered to paying subscribers and has entry as second class matter in its local post office; that a copy of each issue has been filed with the State Historical Society, St. Paul, Minnesota;

That there has been on file in the office of the County Auditor of Lincoln County, Minnesota, the affidavit of a person having knowledge of the facts, showing the name and location of said newspaper and the exact date of the conditions constituting its qualification as a legal newspaper.

That the Notice hereto attached was cut from the columns of said newspaper, and was printed and published in the English language, once each week, for 029 successive weeks, and it was first published on Wednesday, the 23rd day of May, 1970, and thereafter on Wednesday of each
