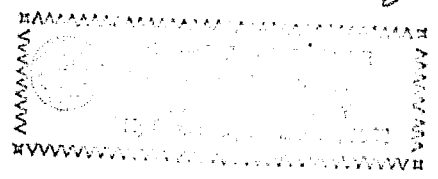

ORDINANCE NUMBER 119
VILLAGE OF FOLEY
BENTON COUNTY MINNESOTA

WHEREAS, a certain petition dated May 6, 1970, requesting annexation of the territory hereinafter described was duly presented to the Council on the 18th day of March, 1970; and

WHEREAS, the quantity of land appraised within the area described in the petition and bounded as described is approximately 73.66 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the Village Limits;

THE COUNCIL OF THE VILLAGE OF FOLEY MINNESOTA ORDAINS AS FOLLOWS:

That the 1967 Code of Ordinances of the Village of Foley be amended by adding Section 100:05 to read as follows:

Section 100:05 (1).

The Village Council hereby determines (1) that the annexation will be to the best interest of the Village and to the territory affected; (2) that the territory described herein abuts upon the Village Limits and is suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 100:05 (2) Territory Annexed.

The corporate limits of the Village are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

The West Half of the Northwest Quarter ($W\frac{1}{2}$ of $NW\frac{1}{4}$), Section Twenty-five (25), Township Thirty-seven (37) North, Range Twenty-nine (29) West, Fourth Principal Meridian, excepting therefrom the following described tracts, to-wit:

1. The North Fifty (50) rods of the South Fifty-two (52) rods of the West Sixteen (16) rods thereof;
2. The East Two Hundred Thirty-seven and two-tenths (237.2) feet of the South Two Hundred Twenty-five (225) feet of that part thereof lying northerly of the northerly right-of-way line of Minnesota Trunk Highway # 23.
3. Commencing 264 feet east and 33 feet north of the West Quarter corner of said Section 25, said point of beginning being on road right-of-way; thence North and parallel to the West Section line for a distance of 150 feet; thence East and parallel to Quarter line a distance of 110 feet; thence South and parallel to West line a distance of 134.55 feet, said point being on the North right-of-way line of Trunk Highway #23; thence Southwesterly on a two degree and Thirty minute curve for a distance of 64.1 feet; thence West a distance of 48.4 feet to the point of beginning and there terminating, said tract containing 0.37 acres, more or less.

Section 100:05 (3) Filing.

The Village Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission, Secretary of State, County Auditor, and the Clerk of the Gilmanton Township Board.

Section 100:05 (4) Effective Date.

This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 100:05 (3).

Passed and adopted at the regular meeting of the Village Council on the 2nd day of June, 1970 by unanimous vote of all members present.
